Different Ways to Apply Online

Swansea U3A Membership Management System

The Swansea U3A website includes a Membership Management system useable from any web browser. As a member you will be able to login to member's only pages using your email address and a password that will be sent to you. If any of your contact details change you can edit them through your **Profile** - just click on your name after logging in.

Join Us

Visit www.u3aswansea.org.uk and click the **Join Us** tab. Select a Membership level. Enter your email and fill in your details. When you **Confirm** you will be taken to your **My Profile** page.

Renewing

Every year around the beginning of July you will be sent a Reminder to renew your membership to Swansea U3A year commencing 1st October.

Pay by Credit/Debit Card

Click on the **Pay Online** button. You will be taken to a PayPal screen where you can pay through PayPal . Select the Pay with a Credit or Debit Card at the bottom of the right-hand column. **You don't need a PayPal account for this. You will be a guest of Swansea U3A PayPal.**

Pay by Direct Debit

If you want to pay by *Direct Debit* do **not** press the Pay online button. Click on the **Members** tab then **Direct Debits**, in the side bar menu to the left. Follow the instructions in the left-hand column.

These are the preferred and secure methods of paying, however you can pay by cheque or cash if you prefer.

Cheque - If you want to pay by cheque do not press the Pay online button. See above for details of cheque payment.
